



### **Concept**

The Gatewood Club is a wholesome family oriented organization. The purpose of the Gatewood Club is to provide for its members an outstanding facility where they can meet with their friends, entertain their guests and enjoy the very finest recreational facilities in a setting of quiet elegance.

### **Location**

The Clubhouse is located in the heart of Gatewood. Members and their guests delight in the spectacular and expansive view of the tranquil lakes and their wooded shorelines.

### **Social Facilities**

Club Social facilities include a spacious dining room, dance floor, intimate lounge, and five private rooms that may be rented.

### **Tennis Facilities**

Members enjoy the use of four Laykold tennis courts and six clay courts, all with ample lighting, a Pro Shop and full-time Tennis Professional.

### **Pool Facilities**

Members enjoy the use of our large Z-shaped pool that is also a perfect place for an outside event. The pool is fully staffed and features a well-stocked snack bar.

## **Membership Categories**

The Board of Directors has determined that membership in the Gatewood Club shall be either through property ownership or by invitation. Membership at Gatewood entitles the parents and single children residing in the home to a membership. The child of an adult member who is nineteen years of age or older, but less than twenty-five, who is enrolled as a full time student in an accredited scholastic program will be allowed to participate as a family member. **Otherwise, this person will need to apply for individual membership.** The following categories of membership have been established.

Clubhouse individual rooms or entire clubhouse may be rented for special events at a discounted rate for members.

### **Property Owners**

Property ownership in Gatewood entitles full club privileges of tennis, swimming, and social recreation.

### **Tennis Membership (Family or Individual)** *(You may add a pool membership for a \$350 annual fee)*

Tennis members enjoy the use of the tennis facility and all special member events held at the clubhouse.

### **Tennis Young Professional Membership** *(You may add a pool membership for a \$350 annual fee)*

Tennis members enjoy the use of the tennis facility and all special member events held at the clubhouse.

### **Pool Membership** *(\$500 annual fee)*

Pool members enjoy the use of the pool facility and all special member events held at the clubhouse.

### **Corporate Membership**

These memberships are issued in the name of a firm, corporation or group and assigned to an individual for use. On approval by the Admissions Committee, and payment of a transfer fee, these memberships are transferable to a successor within the firm.

### **Non-Resident Member**

Non-Resident members must maintain their principal residence and business address outside the adjacent county area.

**As a Gatewood pool member you may bring guests for a \$10.00 per guest charge. Please note however, non-member guests will be allowed no more than 10 visits per calendar year. The member must sign in his or her guest with pool staff before swimming. All guests must be accompanied by a member. For example, guests may not sign in under a member's name if the member is not present.**

*You will receive a monthly statement that will include any charges such as refreshment charges, guest fees, etc. These charges are due and payable by the end of each month in which you receive your statement.*

**Payment Schedule**

Billing Cycle Statement Includes:      First through the end of each month  
Charges – Pool Snack Bar

Delinquent Accounts:                      30 Days – 1 ½% monthly finance fee  
    60 Days – 1 ½% monthly finance fee plus \$25.00 per month late charge  
    90 Days – 1 ½% monthly finance fee plus \$50.00 per month late charge  
If at any time this account must be turned over to our attorney for collection of unpaid balances, the member will be responsible for all attorney's fees and court costs.

All resignations must be in writing and will be effective as of the date that it is received in our office.
